

Kitchener Rangers Koolest Seats in the House OFFICIAL RULES AND REGULATIONS

1. TO ENTER the Kitchener Rangers Koolest Seats in the House contest (the "Contest") simply visit the web site located at www.koolfm.com, click on the Contest page, complete and submit your entry by following the instructions found on the site. In the event of a dispute, entries received on-line shall be deemed to be submitted by the "Authorized Account Holder" of the email address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries must include your first and last name, mailing address, email address, age, ten digit daytime and evening telephone number. Limit of one (1) entry per individual. If it is discovered that you attempted to enter more than once, all your entries will be void. Entries will be rejected if entry form is not fully completed and received during the Contest Period. Illegible entries, or mechanical reproductions are ineligible. Contest starts on Monday, September 1, 2008 at 12:00 a.m. Eastern Time ("ET") and closes on Sunday, March 8, 2009 at 11:59 p.m. Eastern Time ("ET") (the "Contest Period"). There is one (1) prize per home game (the "Prize") consisting of two (2) home game tickets to be won from among all the eligible entries received up to the applicable draw date. No purchase necessary. Void where prohibited.

2. The contest sponsors are CFCA-FM (Kool FM) a division of CTV Limited and RAF Enterprises Inc, operating as The Forbes Automotive Family (hereinafter referred to as the "Contest Sponsors").

3. To enter and to be eligible to win, entrant must be a legal resident of Ontario, and be eighteen (18) years of age or older. Employees and their parents, siblings and children, and persons domiciled with an employee of any of the Contest Sponsors, their agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. A winner of a Kool FM Radio contest in the two (2) months preceding the start of this Contest (including persons designated by such winners to take ownership of prizes) are not eligible to enter.

4. Prize - There is one (1) Prize per home game consisting of two (2) tickets to a Kitchener Rangers home game. Approximate retail value of the Prize is Thirty Six Dollars (\$36). Winners are responsible for transportation to and from the game and all additional expenses. All game ticket winners will be eligible to attend the Grand Prize reverse elimination draw to be held after the final home game of the season on Wednesday, March 18, 2009. The Grand Prize will consist of a pair of Kitchener Rangers 2009/2010 season tickets. At the conclusion of the 2009/2010 season, the Grand Prize winner will have the option to renew the season tickets at his/her own expense. Approximate retail value of the Grand Prize is \$1,100.00. The runner-up in the reverse elimination draw will win a team autographed Kitchener Rangers Jersey. Approximate retail value of the Runner Up Prize is \$300.00.

5. Prizes must be accepted as awarded. Prizes may not be sold, transferred and are not convertible to cash. Contest Sponsors reserve the right to substitute a Prize in whole or in part in the event that all or any component of a Prize is unavailable. Prize winners are solely responsible for all costs not expressly described herein.

6. On the Monday immediately preceding a Friday, Saturday or Sunday home game and the Monday eight (8) days in advance of a Tuesday home game a random draw for two (2) tickets to the applicable home game will take place at Kool FM in Waterloo, Ontario by the Promotions Department of the Kool FM from among all eligible entries received to date during the Contest. The first entry drawn will be eligible to win the prize. The odds of winning the prize will depend upon the total number of eligible entries received. The odds of winning the Grand Prize will be one in thirty four (1 in 34). The Promotions Department of Kool FM, acting reasonably, will attempt to contact potential winner by telephone immediately after the draw. In the event the potential winner cannot be contacted within two business days after the draw, he or she will be disqualified and an alternate potential winner will be drawn. In conducting the contest, Kool FM Promotions Department has the full and absolute discretion to disqualify any potential prize winner who fails to respond on the phone or whose response cannot be heard by such Kool FM representative, and the Contest Sponsors shall have no liability or responsibility to any caller so disqualified. Proof of identification must be provided upon request. In order to be declared a winner, potential winners must first correctly answer, unaided, a time limited mathematical skill testing question administered by Kool FM. Contest Sponsors reserve their right to modify the Rules without materially affecting the terms and conditions hereof. The Contest Sponsors reserve their right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Rules or otherwise in a disruptive manner. Any attempts to deliberately damage the Contest web site or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made the Contest Sponsors reserve their right to seek remedies and damages to the fullest extent of the law.
